Viral V. Acharya is the C.V. Starr Professor of Economics in the Department of Finance at New York University Stern School of Business. He is a research associate of the National Bureau of Economic Research in Corporate Finance and the European Corporate Governance Institute, and a research affiliate at the Center for Economic Policy Research.

Keynote Speaker

His distinguished career spans academia, central banking, and economic research, including service as deputy governor at the Reserve Bank of India (2017-19) and resident scholar at the Federal Reserve Bank of New York (2022-23).

A renowned expert in financial sector risk and regulation, Dr. Acharya has received numerous prestigious honors, including the Alexandre Lamfalussy Senior Research Fellowship and the Banque de France – Toulouse School of Economics Junior Prize. He has been consistently recognized as a Clarivate Analytics Highly Cited Researcher (2020-22).

Currently, he serves as an editor of the Journal of Law, Finance and Accounting, and holds board positions with the American Finance Association and Financial Intermediation Research Society. He is a scientific advisor to Sveriges Riksbank and a member of the Climate-Related Financial Risk Advisory Committee of the Financial Stability Oversight Council.

Dr. Acharya holds a Ph.D. in finance from NYU-Stern and a B.Tech in computer science and engineering from IIT Mumbai. His research focuses on systemic risk in the financial sector, including emerging challenges related to pandemic and climate change impacts.
